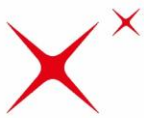

The Company hereby agrees that the Bank shall be entitled, at its sole discretion, to carry out any instructions as it understood them and the Bank's interpretation of such instructions shall be binding and conclusive on the Company.

A transaction that is a forward, swap, futures, option, cap, floor, collar or other derivative transaction on one or more interest rates, currencies, commodities, equity securities, equity indices or other equity instruments, debt securities or other debt instruments, economic indices or measures of economic risks or values or other benchmarks against which payments and deliveries are to be made; or
