If a client applies Entrepreneur's Account and deposits USD\$3 million, the daily interest amount will be:

99,999.99 * 0.10% / 360 = 0.28

400,000 * 0.40% / 360 = 4.44

1,000,000 * 0.75% / 360 = 20.83

1,000,000 * 1.00% / 360 = 27.78

500,000.01 * 1.50% / 360 = 20.83

當日利息總金額約為美元74.17元 ·

The daily interest amount will be USD\$ 74.17.
