新臺幣活期存款帳戶依該帳戶每日日終新臺幣餘額適用之階梯式利率依級距分段計息，最低起息金額為新臺幣1萬元(含)，專案牌告利率說明如下：

NTD savings accounts are paid at the tiered interest rate applicable to the daily end-of-day NTD account balance.

The minimum balance you can earn interest on is NTD\$ 10,000. The interest rate is as follows:

假設某公司於本行開立「新興企業展業帳戶」，並存入新臺幣4600萬元，當日利息的計算方式如下：

If a client applies Entrepreneur's Account and deposits TWD\$46 million, the daily interest amount will be:

$$999,999 * 0.03\% / 365 = 0.82$$

$$4,000,000 * 0.05\% / 365 = 5.48$$

$$5,000,000 * 0.10\% / 365 = 13.70$$

$$36,000,001 * 0.15\% / 365 = 147.95$$

當日利息總金額約為新臺幣168元

The daily interest amount will be NTD\$ 168.
